




10A 3 Pole & Fan Isolation Switch

Additional Information

Ensure that the mains supply is isolated before commencing installation and refer to the circuit diagram with the relevant product.

Bare earth cables must always be covered with appropriate sleeving and wired to the earth terminal. All white moulded accessories are manufactured using Urea Formaldehyde, which has similar inherent properties to antimicrobial additives that inhibit the growth of infectious diseases. All products were independently tested and achieved a 99.9% kill rate across all four types of the strains of bacteria - MRSA, E-Coli, Salmonella, and Klebsiella Pneumoniae.

PRW020 and PRW021 are not interchangeable with the MiniGrid System however, a Fused Fan Isolation Switch can be created using componenents from the MiniGrid System
